OSJ is excited to announce that both of our proposed bills (changes in the law) have been introduced by supportive legislators. We need to work together to get them passed!

#### **HB6633 - Reform Address Verifications**

# Hundreds are arrested every year because of late paperwork. The homeless are automatically at risk of a felony arrest because they lack an address. Another arrest can mean a lost job or a probation violation; another felony can make it harder to get a job, get an apartment or get your life back. By allowing for phoning-in of address verifications, and by eliminating the mandatory felony, our bill will keep the verification letter from running your life.

#### **HB6367 - Early Termination of Probation**

The average term for probation in Connecticut is 11 months. For those on the registry, it is usually 10-35 years. Excessive probation just keeps people down and is expensive for the state, without making anyone's life safer. Everyone should be able to ask the courts to reduce probation once it no longer serves a purpose.

We at OSJ believe it is a future worth fighting for. NOW we need you and your friends and family to speak up. Representatives and Senators need to hear WHY these laws must pass.

They hear voices like ours in other states: Utah Sen. Todd Weiler has proposed legislation to reduce the time on the registry. Sen. Weiler said, "This is like my third or fourth attempt at the "sex offender" database, only because I keep on getting contacted by these families saying, 'We feel like this has become a lifelong sentence, and we don't think it's fair.'" Proposed bill would shorten time on Utah's registry for some "sex offenders | KSL.com

In North Dakota, the House recently voted 62 to 29 to allow those registered to ask the courts to get off the Registry early...North Dakota House passes bill to allow sex offenders to apply for early removal from registry - InForum | Fargo, Moorhead and West Fargo news, weather and sports

In Connecticut, people like you changed the minds and votes of conservative senators, convincing them that the registry is a 'scarlet letter' and winning their support in getting more than 500 people off of the Registry. [Senate Hearing on SB1194 - Sen. Winfield and Sen. Kissel]

Imagine what life could be like if you didn't have to worry about a felony charge for a late letter. And how would it feel to reduce your probation term to 5 years?

Approximately a year ago, OSJ began its PARDON PROGRAM. We are delighted to continue this work with the latest group, our 3<sup>rd</sup> cohort, that began in January. Our next group will start in June 2025. We are looking for 10 new people to work with us from Hartford and another 10 outside of Hartford. Transportation is important because there are 4-6 group classes in Hartford for everyone including those from outside of Hartford.

- Must be 5 years or more from last conviction.
- Good track record for leading a law-abiding life.
